Foundation launches youth program amid steady growth

Modest though it was, endowment growth was registered in 2011 by the Community Foundation of Mount Vernon & Knox County, as the national and world economies sought to accelerate the pace of their recoveries. The Foundation's year-end market value of \$36,120,651 reflected an increase of 1.3 percent over year-end 2010, thanks to the continued recovery of our investment portfolio, and the receipt of \$1,446,628 in new charitable gifts. This was the eighth consecutive year in which contributions to the Foundation exceeded \$1 million.

While 2011 may not have been a spectacular financial success for the Community Foundation, the year is certain to be remembered for another signature achievement: the establishment of its Youth Philanthropy Initiative (YPI, or "why-pie" for short). In a personal recollection beginning on page 24 of this annual report Ellen Blanchard, a 2012 Kenyon College

graduate from Petoskey, Michigan, who is singularly responsible for YPI's successful debut, reveals her dedication to youth philanthropy in general, as well as to the 12 extraordinary local high school students

she deftly advised. Not to steal Ms. Blanchard's thunder, but her timely appearance on our doorstep (almost literally) in January of 2011 enabled us to realize one of the board of directors' long-range development objectives.

Four new funds added to Community Foundation

This section of the annual report is where we traditionally celebrate charitable funds that are appearing for the first time in our catalog of Community Foundation funds, beginning on page 8. We are proud to report four new funds were created in 2011 – all of them intended to provide college scholarships for accomplished area students:

The William Burgett Builder & Contractor Scholarship Fund was created in honor of the Kokosing Construction Company founder with a \$25,000 contribution from family members Brian and Carol Burgett, Janenne Burgett, William B. and Sarah Burgett, James Matusik and Dean and Marcia Rinehart. Beginning in 2012 the fund will provide a scholarship to a student from either Fredericktown High School or Northmoor High School in Morrow County, who is pursuing post-secondary education in the construction field.

The Daughters of the American Revolution Lucy Knox Chapter Frances Sturtevant Scholarship Fund was established with a \$5,000

contribution from the local D.A.R. chapter. By establishing this fund, current D.A.R. members hope to honor their late regent Frances Sturtevant, who provided funding for a scholarship program. Eligibility for the award is limited to applicants who are natural or adopted children, grandchildren, great-grandchildren, etc. of living or deceased members of the Lucy Knox Chapter, D.A.R.

The Raymond E. Kinney Scholarship Fund was created with memorial contributions for the late Centerburg native. It is the family's desire to support the education of area high school graduates who are pursuing careers in emergency services. The scholarship will be presented for the first time in 2013.

The W. Joan Levering Scholarship Fund will provide scholarships to Fredericktown High School girls pursuing a degree in one of the following disciplines: business administration, health services administration or management, nursing, physical therapy, occupational therapy or speech therapy. The fund was created with a contribution of \$13,000 from Joan Levering, herself a successful health care administrator with Levering Management, which operates The Living Center assisted living residence and the Country Court Nursing Home locally, as well as other area facilities.

Two retire; two join Community Foundation board

Board members Sally A. Nelson and Douglas O. Brenneman, whose second five-year terms expired in 2011, joined the Foundation board in 2001. Their elections that year, along with those of previously retired board members Ron Godfrey and Dr. Deborah Reeder, marked the final phase of a three-year board expansion from five members and a secretary to eleven members and a secretary. Sally's and Doug's board service coincided with a 60 percent growth in Foundation asset value, and a doubling of our annual distributions for grants and scholarships.

Both retiring members played instrumental leadership roles, with Doug serving as vice chair of the board, and Sally as board treasurer and chair of the development committee. Sally continues to serve as manag-


ing partner of Nelson & Nelson, CPAs, while Doug is retired as CEO of Brenneman Lumber Co. The wisdom and dedication of these retiring members has greatly benefitted the Foundation over the past decade.

As is typically the case leaders with excellent community service credentials were available to fill these Foundation board vacancies. Attorney Kim Rose, a member of the Critchfield, Critchfield & Johnston law firm, will serve on the Foundation's development committee, as will local CPA Kurt Schisler, of Kurt Schisler, Inc., who also assumes the office of Foundation treasurer. Both Kim and Kurt bring a wealth of community knowledge and non-profit community service to their new roles with the Community Foundation of Mount Vernon & Knox County. Their initial terms of service continue through December 2016. You can see a complete list of current Foundation board members and their photographs beginning on page 28 of this report.

Unrestricted grants meet emerging community needs

The Foundation awarded more than \$325,000 in unrestricted grants to Knox County non-profit entities, as follows:

• Danville Sanctuary Community Action — Support for a capital campaign to renovate a donated residential structure that houses an array of Sanctuary social service providers meeting the needs of Eastern Knox County families, and to construct an adjacent facility for lease by the Danville Branch of Interchurch Social Services, \$60,000 (See pages 5-7 for more information).





- Mount Vernon YMCA Capital Improvements To address critical needs at the North Main Street facility, including physical improvements and equipment replacement for its fitness center, \$40,000.
- Danville Athletic Boosters A collaborative effort to construct a running track for interscholastic competition, training and for general community use, \$40,000.
- Central Ohio Technical College A grant from the Harold and Roberta Johnson Fund for economic development to complete the lower level renovation of Ariel Hall as part of COTC's Downtown Mount Vernon campus expansion, \$26,250.
- Mount Vernon Nazarene University A grant from the Harold and Roberta Johnson Fund for economic development to complete construction of the MVNU School of Nursing & Health Sciences, located in the former Montgomery Ward/Mount Vernon Sewing Center building, adjacent to Buchwald Hall in Downtown Mount Vernon, \$26,250.
- Salvation Army For the third consecutive year the Foundation awarded an economic stabilization grant to a local charitable organization, upon the recommendation of the executive committee of the United Way of Knox County. Such grants may be used to supplement regular operations of an agency when economic conditions significantly threaten its charitable mission. The local Salvation Army was able to use this infusion of local operating support to leverage additional operating grants from the regional office of the Salvation Army, \$25,000.
- Centerburg Local Schools A grant to assist with the purchase of equipment for the Centerburg Wellness Center, \$10,000.
- HopeNow Inc. Purchase of a used box truck enabled the Hope-Now organization to more efficiently pick up and deliver used home furnishings for needy area families. Previously, the task was undertaken in piecemeal fashion using the personal vehicles of volunteers, \$10,000.
- Saint Vincent de Paul School The Foundation provided asbestos removal assistance in connection with a gymnasium floor replacement project in the school, \$6,325.
- Knox County Educational Service Center For the eighteenth year the Community Foundation of Mount Vernon & Knox County was the principal funder of the Youth Enrichment Series (Y.E.S.) which enables every elementary school student in Knox County to attend a live musical or theatrical presentation in the Knox County Memorial Theater, \$5,000.
- Danville Foundation for Student Achievement Matching funds were provided for a start-up academic booster organization that intends to enhance the educational experience for Danville students, \$5,000.
- Ohio Grantmakers Forum A portion of the Community Foundation of Mount Vernon & Knox County's dues to OGF is paid in the form of a grant. OGF, a statewide consortium of community, private and corporate foundations, informs us about changes in legislation affecting philanthropy and is a forum for charitable organizations to share best practices in fund-raising and grant making, \$3,318.
- The Village Network Sponsorship of the Village Network's first "Gathering of Friends" enabled the organization to connect with more than 100 local donors in the context of a tour of three historic homes. Along the tour route guests enjoyed elegant food contributed by The Alcove, Ariel Corporation and AVI Foodsystems at Knox Community Hospital, and became acquainted with The Village Network's Children's Resource Center, a local residential facility for at-risk children and adolescents, \$3,000.
- Knox County Renaissance Foundation. A second grant was provided to assist with renovation of the historic Odd Fellows Building in Downtown Mount Vernon, \$3,000.



Foundation Fact: The total dollar amount of grants awarded from the Community Foundation's 56 unrestricted funds in 2011 was \$426,326.

- Danville Athletic Boosters Purchase of wrestling mats for a new junior high, high school and "biddy" recreational wrestling program projected to serve up to 80 Danville youths, \$3,000.
- Science-Play Initiative (City of Mount Vernon, fiscal agent) The Foundation awarded a capacity building grant to this all-volunteer organization, which seeks to provide stimulating science-based experiences to children of all ages, \$3,000.
- Knox County Educational Service Center Fulfillment of a 2010 grant for the "Play to Talk" conference presented by Dr. James MacDonald, in support of families with children experiencing delays in talking, due to autism, Asperger's, Down Syndrome and other developmental conditions, \$3,000.
- Knox County Habitat for Humanity Grant provided for the purchase of a pallet truck to be used at Habitat's new ReStore retail space. The resale of salvaged building supplies provides a steady stream of funding for the organization's home building mission, \$2,945.
- Talk Through Me Project (Station Break Senior Center, fiscal agent) This all-volunteer effort brings technology to older Knox Countians living in retirement facilities, allowing them to connect with family and friends electronically, and to capture personal histories, \$2,362.
- Knox County 4-H Equipment necessary for conducting canine agility programs was acquired with this grant, \$2,014.

- Knox County Community Concerts Association Funding for the first annual Vaughn Wiester Scholarship Fund Benefit Concert was provided through the Foundation's event co-sponsor, \$2,000.
- United Way of Knox County The Imagination Library, a creation of country music star Dolly Parton, provides monthly reading material to young readers through this county-wide program coordinated by our area United Way program, \$2,000.
- Compassionate Friends, The local chapter of this support organization for parents of deceased children has constructed an "Angels of Remembrance" memorial to their loved ones near the entrance to Knox Woods on Coshocton Road, \$2,000.
- Equine Assisted Therapy A grant was provided to this Centerburg-based program to assist with the renovations of a horse barn, \$2.000.
- A Hand at Home (Station Break, fiscal agent) A capacity building grant was provided to this start-up organization in Gambier, which seeks to improve the lives of local seniors through neighbor to neighbor assistance with household activities, \$2,000.
- Fredericktown Local Schools Completion of a 2010 commitment to Fredericktown Local Schools to study native plant species, \$2,000.
- Knox County Commissioners Replacement parts for the Steinway concert piano residing in the Memorial Theater was enabled by this grant. Labor to complete the project was donated by Kenyon's John Reitz, himself a concert pianist, \$1,592.
- Fredericktown Community Foundation Community Foundation sponsorship of the first annual 5K Run-Walk assisted our partner philanthropic organization in its fund-raising venture, \$1,500.
- Knox County Ohio State Alumni Association Sponsorship of an early summer concert appearance by the OSU Alumni Marching Band in the new Kenyon College athletic complex added scholarship dollars to the Knox County OSU Alumni Fund, \$1,500.



As the 2011 Community Foundation Annual report goes to press we are watching Rolls-Royce's new 35,000-square-foot office building being craned into place on the northwest corner of North Sandusky and East Chestnut Streets. The \$10 million project, which will house some 300 Rolls employees, replaces the Rolls Tech Center on North Adams Street (formerly the Mount Vernon Bridge Company). The Community Foundation's Harold and Roberta Johnson Economic Development Fund and the William and Peggy Stroud Family Fund has contributed \$71,000 in 2012 to the City of Mount Vernon to acquire the former Certified gas station property (pictured lower right), which Rolls-Royce has improved to maintain parking capacity. The project also involves future intersection and landscaping improvements at the site.

- Community Garden Initiative (First Congregational United Church of Christ., fiscal agent) Purchase of equipment to facilitate community gardening was enabled by this grant, \$1,500.
- Knox County Convention & Visitors Bureau Support for the organization's pursuit of National Historic District designation for Downtown Mount Vernon, \$1,500.
- Mount Vernon B&O Depot Restoration Committee Co-sponsorship with the Ariel Foundation of the fall 2011 exhibit of prints by iconic steam railroad era photographer O. Winston Link, \$1,500.
- Knox County Health Department Financial assistance to underwrite the cost of a community needs assessment, \$1,500.
- Knox County Health Department Grant for the purchase of patches used in the community-wide "Knox Out Tobacco" smoking cessation program, \$1,500.

Danville finds sanctuary in teamwork

Community completes social services facilities on-time and on-budget

Improving the quality of life for people in Danville and Eastern Knox County has been the mission of Sanctuary Community Action for nearly 20 years. Last year a community effort of immense proportion demonstrated the breadth and depth of that mission in its community. Convinced of the commitment of the greater Danville community and the Sanctuary board, the Community Foundation of Mount Vernon & Knox County signed on as a funding partner for a capital improvement project that would change the face of the organization for the better, and for decades to come.

The story of this little community that could – and did – actually begins in 1994 when the Association of Danville Ministers (ADAM) organized Sanctuary Community Action to provide centralized health, education and social services to eastern Knox County.

From the outset a vast array of services were offered under The Sanctuary umbrella, including the Danville branch of Interchurch Social Services, Life-Line Screening, WIC (Women, Infant and Children) nutrition programs and immunizations, women's health screenings, mobile mammography, Safety Town for kindergarten children, Amish Safety Day, home delivered meals, homemaker

services and lawn mowing program for individuals 60 years of age and older. The Sanctuary has no church affiliation and performs its coordinating function without the assistance of government money.

perating for years out of the former Danville Church of Christ at 302 South Market Street – which had been acquired by the ministerial association with the help of an anonymous gift from a community member – Sanctuary Community Action and Interchurch Social Services have thrived. The Sanctuary's offices and clinics were

located in the top floor of the old church, while Interchurch, with its independent board and staff, operated a thrift store and food pantry below. Although the property was paid for, and services were being provided for the community, there remained some issues, according to Sanctuary Director Barb Mickley.

"Our second floor space was not handicapped accessible, and over time that became an issue with many of our clients." For example, the Sanctuary's GED program, a path to high school diploma equivalency, had to be essential services to thousands of area residents each year.

he Community Foundation of Mount Vernon & Knox County board had provided financial assistance along the way, enabling the Sanctuary to get the most out of its limited physical space for as long as it could. The pathway to a long-term solution for Sanctuary Community Action started coming into sharper focus in October 2010, about the time Mark Ramser — though not a Danville Community member—bought and donated to the Sanctuary what became known

however, Ramser would be a bit more hands-on, agreeing to serve as co-chair of a fund-raising committee with Phyllis Colopy, manager of the Danville branch of First-Knox National Bank, to renovate the yellow house as a new home for The Sanctuary and to construct a new adjacent facility that could be leased to Interchurch for its operations. The proposed fundraising goal was \$420,000.

"From the outset, we knew it would take a combination of private donations and grants – from the Community Foundation and other foundations – to make

all this possible," said Ramser. Though Ramser accurately predicted The Community Foundation of Mount Vernon and Knox County (as well as the Richard and Arlene Landers Foundation and The Energy Cooperative's "Operation Roundup) would find merit in the project, he might not have foreseen how the Danville Community at-large would coalesce around the

Community member Don Hawk, who donated his services as project manger, remembered the committee's presentation to the Community Foundation Distribution Committee: "We went to them in February of

2011 with our hand out because we definitely needed some help. The Community Foundation initially granted \$60,000 for the project, which, as it turned out, was the largest single grant they made that year. That definitely got us going." From there the fund-raising effort spread to all of the area churches. "Most congregations made a donation, as did many individuals within the various congregations," said Hawk.

Bruce Hawkins, Ramser's successor as chair of the Community Foundation of Mount Vernon &

discontinued because of the lack of accessibility. In general visitors to the Sanctuary had to walk up an outside iron stairway, which could be hazardous during the winter months. "It was God's blessing no one ever fell down the stairs, Mickley said."

A vision of what lay ahead for the Sanctuary took shape years ago. "We knew we needed more space early on, as well as a building that was accessible to everybody," said Mickley, even as the organization functioned in less than desirable quarters, delivering

simply as "the yellow house" to the south of the old church. For Ramser, who was completing his 14th and final year on The Community Foundation of Mount Vernon & Knox County board, buying real estate for donation or bargain sale to a charitable organization was something he had done several times before. "The Sanctuary itself is a coordinating organization. A number of agencies provide services under one roof. That's why I thought the project was important to the Danville community," Ramser said.

In this community project,

Knox County board, knew the project was destined for success from his past experience as superintendent of Danville Schools. "We look for evidence of matching funds and broad-based local support, as well as assurance that a project is going to generate benefit for the community. This particular project seemed to have it all. I believe it stands as a model for other communities with a dream, who come to the Foundation in search of financial assistance," Hawkins said.

ith enough cash in hand to get underway, renovation of the yellow house began immediately that winter with Hawk, who had previously worked on an expansion project at the Knox County Agricultural Museum at the Knox County Fairgrounds, pinching pennies and effecting cost-savings every way possible.

"Don donated all his time and was a master at getting others to do likewise," said Barb Mickley. New plumbing and wiring were installed in the house at a deep discount by Mickley Plumbing and Heating and Buckingham Electric, while Mullet Cabinetry of nearby Holmesville supported the Mennonite community's donation of labor by contributing all the cabinetwork for the facility. "This outpouring of generosity kept me going – everybody kept coming forward wanting to do their part for the project," Hawk said.

By no means was the process a breeze. "We constantly worked on the budget," Hawk said, " and the elevator to make the building American Disabilities Act accessible to the second floor was surely a budget-breaker. We opted to install the elevator on the outside of the building. Otherwise, we would have had to reconstruct the entire second floor of the house."

"We succeeded in blending it into the house," said Mickley of the new elevator, which was encapsulated around a fire escape." Hawk credits Steve Stein of JBA Architects of Newark, who also donated his services, for maintaining the

historic value and the aesthetics of the house.

"We had made a commitment to the village that we would try to maintain the residential appearance of the structure. We felt the community would be more receptive to fixing up what was already here rather than to tear down and start over. This house had some history to it," said Mickley, who explained it was constructed sometime between 1908 and 1914 from a kit delivered to the building site by Sears.

All of the original woodwork was retained and was restored to the degree possible. Original flooring was kept in the front room of the house, which now serves as

Small's Sand and Gravel and Small's Concrete came forward to provide discounted materials for the foundation, and Latorre Concrete Construction donated all the labor for footers and concrete walls, which were dug on July 5. Even the utility companies pitched in, Hawk said, mentioning American Electric Power's offer to trim trees and to reroute electrical lines for the new building.

Contractor Alvin Yoder, who had led the construction effort in the yellow house, brought up the idea of an Amish frolic – similar to an Amish barn-raising – to frame the new building in a single day. After consulting with his steering committee Hawk gave Yoder the

pancy in September, though finish work continued on the building through November.

oy Harris, director of Interchurch Social Services, participated in the planning for the new structure, and her staff and volunteers prepared and served meals for the Amish work crews on the day of the frolic. "It was a wonderful, worthwhile project that proved to be the answer to prayers," said Harris. "The facility is now on one floor, weatherized and is much more economical to operate. Across the board Interchurch is seeing more people. Eastern Knox County definitely has a need, and there are more and better opportunities to serve people." Interchurch



a reception area. An old kitchen and dining room were converted into three medical exam spaces and an office. A few doors had to be refitted to allow a wheelchair to pass through. Trim was saved around many doors and windows from the old house. Renovation was for the most part complete by late summer, by which time work on the new adjacent building was also underway.

green light to proceed and the frolic took place July 23. An Amish crew arrived early in the day to begin framing the building with the help of a donated crane and operator to swing the trusses into place. By noon all the walls and roof trusses were up, and by late afternoon roof decking was completed and prepared for shingling.

The new Interchurch building was ready for temporary occu-

rents the new facility from the Sanctuary and pays for its own utilities and insurance, which is now less because of a much lower fire and accident risk.

As those who witnessed the raising of the new Interchurch building well remember, its north wall was literally within arms reach of the old church, meaning construction of the entrance way would have to wait until the church was demolished. Even the demolition phase of the project attracted volunteer involvement, according to Hawk. Knox County Habitat For Humanity extracted usable windows and doors, as well as valuable trim from the church structure, for resale at its ReStore retail outlet. Also salvaged were a furnace, an air-conditioning unit and copper piping. Members of the Church of Christ salvaged some of

the painted windows, steeple cross and a ladder leading to the steeple. After Hawk was given a "green light" from the Environmental Protection Agency to remove asbestos shingles, members of the Nunda Amish community completed the work, as well as the remainder of the demolition. By mid-November the old structure was completely gone from the site, which now serves as a parking lot for both the Sanctuary and Interchurch operations, thanks in part to a supplemental \$5,000 grant provided by the Community Foundation.

"A lot of people in the Danville community really pulled together both financially and in other ways to support this effort," said Ramser. "I was impressed by the about investing in the community," said Bayer about The Community Foundation of Mount Vernon & Knox County's leadership grant. "Our project was seen by the Community Foundation as grass roots and very cooperative. We didn't use government money of any kind, and we raised all of what was needed in the community. A good portion of the work was completed with in-kind services, and, I believe, from past experience with the Danville community the Foundation had a high comfort level with the people they were working with. As a relative newcomer to the Danville area, what I learned about this community is that there are a lot of really good people with big hearts, who want to help others. I was privileged to be a part of this community effort."

ommunity Foundation Executive Director Sam Barone was quick to echo, "The Sanctuary project is one of the finest community collaborations our Foundation has ever supported. Our board members are gratified that each dollar we contributed to the effort leveraged many times its value in additional donations and in-kind services. All of Danville, including its neighboring Amish and Mennonite communities, worked tirelessly to complete the Sanctuary expansion on-time and on-budget. What more could a funder like the Community Foundation ask for?

Barone added, "I had the opportunity to visit the construction site and was impressed by the resourcefulness of the Sanctuary board in preserving and re-purposing existing facilities, while constructing cost-effective space to meet the needs of their highly-integrated social service programs. There was a home-grown quality to the project that encouraged widespread community participation and created enthusiasm."

Organizations like the Sanctuary do not run themselves, but instead rely on community volunteers to provide both the vision and leadership to fulfill their missions. In this particular instance superb vision and leadership were provided by board president Dennis Rawson; vice president Art Lund; secretary Anita Hollis; treasurer Laurie Vess; and members Dorothy Thompson, Roberta Rawson, Ruth Collier, Mary Ellen Durbin, Roberta Thomas, Corrine Lund, Martha Stuller, Pastor Mary Murtha, Fr. Richard Snoke, Barb Mickley and Amy McDonald.

Everything came together, and though the amount of money that was needed seemed daunting, we were able to accomplish it." Ramser was especially lavish in his praise of Hawk for keeping the project on schedule and on budget.

Steering committee member Rick Bayer, a New Albany resident with a weekend home in nearby Apple Valley, learned of the effort through his attendance at Saint Luke's Catholic Church in Danville. 

Youth Philanthropy Initiative: lessons in the craft of giving

Dear Mr. Barone,

I am Ellen Blanchard, a sophomore at Kenyon College from Petoskey, Michigan. I have been involved with philanthropy since my freshman year of high school, specifically as a member of the Youth Advisory Committee (YAC) of the Petoskey-Harbor Springs Area Community Foundation (PHSACF), and I am currently a member of the Michigan Community Foundation Youth Project (MCFYP) Committee.

Our community foundation established a youth fund in the early 1990s because of the vast number of grants that benefited youth and youth programs. There was also a youth fund initiative by the Kellogg Foundation in Michigan encouraging community foundations to set up committees made up of youth allocating funds to youth. There are over 80 YACs across the state of Michigan, and every summer the MCFYP Committee organizes a summer conference that highlights philanthropic endeavors by youth and youth empowerment. Youth Philanthropy is something that I am passionate about, and I am very curious if a youth committee has ever been considered for the Community Foundation of Mount Vernon & Knox County.

hus began my rewarding journey with the Youth Philanthropy Initiative – a brief inquiry via e-mail to the Community Foundation of Mount Vernon and Knox County, from a nostalgic 19-year-old college student yearning for the chance to empower youth. Now, only 18 months after its inception, the YPI ("Why-Pie") has conducted a needs assessment of more than 600 area youth, has granted nearly \$7,000 to local nonprofits for youth programming, has launched an endowment fund, and is poised to start its second year with twice the membership of its inaugural year.

As my January 2010 email to Sam Barone reflects, midway through my college career I sensed a disguieting absence of youth philanthropy in my life. So I did what any normal college sophomore would do, right? I contacted the executive director of the local community foundation to inquire about youth participation in philanthropy in Knox County. I received an immediate and positive response from Mr. Barone, who eagerly invited me to lunch with him and **Development Committee Chair** Sally Nelson to learn more. I had no idea at the time of the serendipitous nature of our correspondence. Three months earlier creating a youth philanthropy organization had been identified as a priority at the Foundation's strategic planning retreat, even though there was considerable question, according

to Mr. Barone, that the resources to do so were readily at hand. Timing is everything, they say.

I explained to Mr. Barone and Ms. Nelson how I had became involved in philanthropy, thanks to an initiative in the early 'gos that launched 82 youth philanthropy committees in Michigan. The question had been raised among community foundation leaders in my home state, "Why not include youth in the decision making process for the multiple grant requests each year involving young people?"

Below, YPI members share profiles of their respective school districts during a Sunday afternoon meeting in the B&O Depot to develop a country-wide youth needs assessment survey.



After all, youth are experts on youth. Involved adults volunteer, donate money, serve on boards, and attend churches. Young people can be just as active in their communities at school, playing sports, volunteering, and leading service groups. As a bonus, youth serving on a philanthropic committee might be more likely to become philanthropic adults, continuing to volunteer, donate money, and engage with their communities because it was instilled in them at an early age.

Having convinced Sam and Sally of my relative expertise with youth philanthropy - and my willingness to volunteer my services over the remaining two year of my Kenyon College career – we began planning in earnest. Even though I would be spending the first semester of my junior year studying in India, we accomplished a great deal during the summer months, including creating an application process for interested high school students in Knox County, and mapping out a plan for selecting and training students in the basics of philanthropy the following winter and spring. Upon my return from India we hit the ground running.

ur first committee of 12 impressed me from the moment I saw their applications. They represented five schools, participated in many activities including sports, band, newspapers, Key Club, and church youth groups. The application had asked how each would choose to allocate \$1,000 dollars for charitable use in Knox County. The students' responses demonstrated they already had an understanding of community needs, suggesting they would donate to United Way

of Knox County, CareNet Pregnancy Services, the Knox County Park District and the New Directions women's shelter, among others. Our would-be YPI members had engaged themselves in philanthropy even before all knew how to pronounce the word!

The YPI accomplished so much before issuing its first call for grant applications prior to the holidays. In the spring of 2011, Mike Goorhouse from the Council of Michigan Foundations led a full day of training on philanthropy and grantmaking. Three of our members attended the Summer Leadership Conference at Michigan State University, led by the Michigan Community Foundation Youth Project Committee, where they learned even more best practices for youth philanthropy, along with youth funders from the Midwest.

In the fall YPI began meeting two Sunday afternoons per month to plan, distribute, and tabulate a youth needs assessment completed by more than 600 Knox County students. YPI members designed their grant application in October, and at the Community Foundation's annual Partners in Philanthropy dinner in November they officially announced they were inviting grant applications. As a result of the YPI members'

progress report at the Foundation dinner, they received an incredibly generous donation from Mr. Tom Rastin, which effectively doubled the grant pool to which they had been staked to by the Foundation board.

In February 2012 our youth funders reviewed numerous grant applications, interviewed project representatives, and awarded their first grants in the community. The projects funded ranged from a successful robotics club at Centerburg High School, to a tile mosaics project pairing fourth-year Latin Students at Mount Vernon High School with developmentally disabled classmates, to youth-focused outdoor activities sponsored by the Knox County Park District.

Ut the year was far from over. The YPI's attention shifted to replenishing and expanding its ranks for the following year, and making a grant application of its own to the Ariel Foundation to establish a permanent endowment in support of its future activities. At the end of the year the group met for dinner to bid farewell to its five graduating seniors – six if you count me as a graduating college senior – and to welcome 18 new high school YPI'ers for the 2012-13 school year.

As advisor to the Youth Philanthropy Initiative, one thing that stands out from a very successful inaugural year is not necessarily apparent in press releases or financial reports. It is the great friendships that were forged among students from across Knox County as they immersed themselves in the world of philanthropy. YPI members confidently made presentations to Community Foundation Distribution Committee members; they mingled with Foundation donors at the annual meeting; they reached out to their peers at school to discern pressing youth needs; and they engaged non-profits throughout the grantmaking process – all while coming to know and appreciate each others' talents.

The Youth Philanthropy Initiative truly brought together youth, adults, non-profits and the community in a way, I am confident, will benefit Knox County for years to come.

It was an honor to share my passion for community service with these 12 remarkable students, and in turn to be inspired by their own.




