Summer in the City of Mount Vernon, and throughout Knox County, is a cornucopia of free and affordable entertainment, much of it supported by the Community Foundation. The free summer concert series at Ariel-Foundation Park is a case in point. Concerts representing a variety of musical genres take the Schnormeier Event Center stage from early June to late September, when ensembles like the Knox County Symphony, Dogwood Blossoms, and Apple Valley Singers are on hiatus, as is the popular Community Concerts Association of Knox County. A popular addition to the A-F Park series in 2017 was the screening of feature films, reminiscent of summer nights at a drive-in theater. A full-schedule of summer festivals throughout Knox County, Broadway-style musicals like last year's MTVarts staging of *Bye Bye Birdie* (see back cover photo by Scott Swingle), the always entertaining Knox County Fair, and First Friday celebrations sponsored by the Main Street Mount Vernon organization add immeasurably to the quality of life we enjoy locally year-around.

Generous donors, healthy inv accelerate growth of charitab

Future-oriented organizations like the Community Foundation of Mount Vernon & Knox County are fond of commending donors for "planting trees whose shade they may never have the opportunity to lie in." Our New Philanthropy Program, supported the past six years by generous grants from the Ariel Corporation Donor-Advised Fund, may be in the process of altering that proposition.

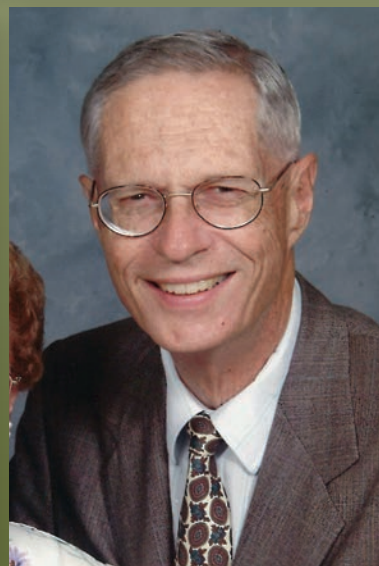

It was Confucious, we are told, who advised, "Study the past, if you would divine the future." Looking back into the Community Foundation's recent financial history, we get a glimpse of what the future might hold for our 73 year-old philanthropic institution.

Just 10 years ago in 2007, the Community Foundation had grown to nearly \$34 million in assets while awarding just more than \$1.5 million in grants and scholarships on an annual basis. Jump forward to 2017, the Foundation holds and invests more than \$70 million in assets. Doubling in size in just 10 years, our capacity to distribute grants and scholarships has increased at a similar pace. During the 2017 program year the Foundation awarded more than \$3.7 million to organizations and students through its competitive grants process, its designated and donor-advised funds, and its generous scholarship program.

The Foundation's growth is attributable to both the incredible generosity of the Knox County community and a sound investment strategy that has reaped the benefits of a strong stock market. Though charitable contributions can often fluctuate greatly year-to-year, the Foundation received contributions in excess of \$5 million in two consecutive years (2016 and 2017) for the first time ever. With the U.S. and global economies continuing to grow and prosper, the Foundation's invested assets generated returns in excess of 13 percent for 2017, resulting in almost \$8 million in investment-related asset growth.

The transformation of the Community Foundation from 2007 to the present day provides a glimpse of what the organization might evolve into 10 years from now. Our donors have witnessed first-hand how partnering with the Community Foundation can help meet and exceed their philanthropic goals. By taking advantage of the New Philanthropy matching contribution program, for example, donors can magnify the impact of their charitable giving.

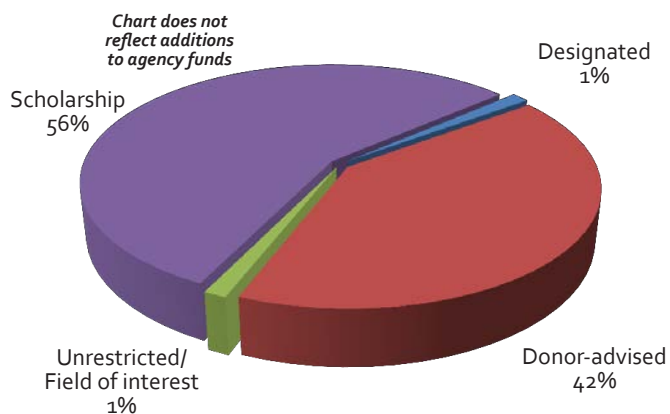

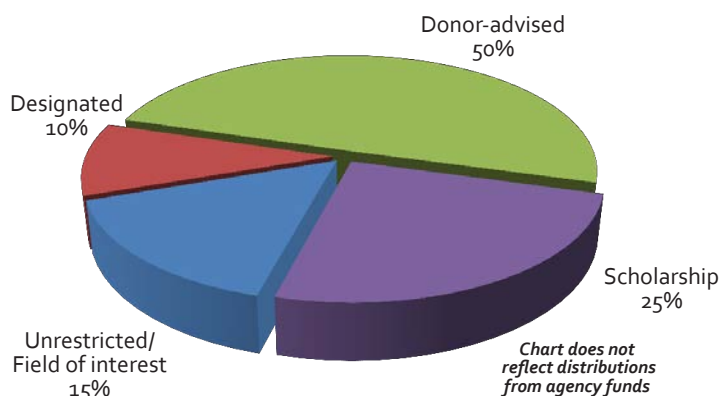

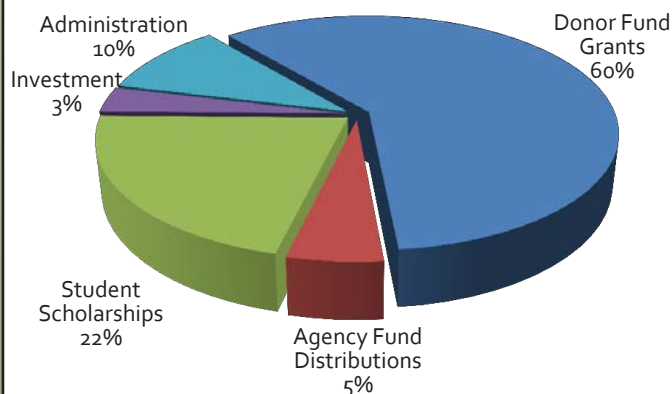
2017 Donor contributions by fund type

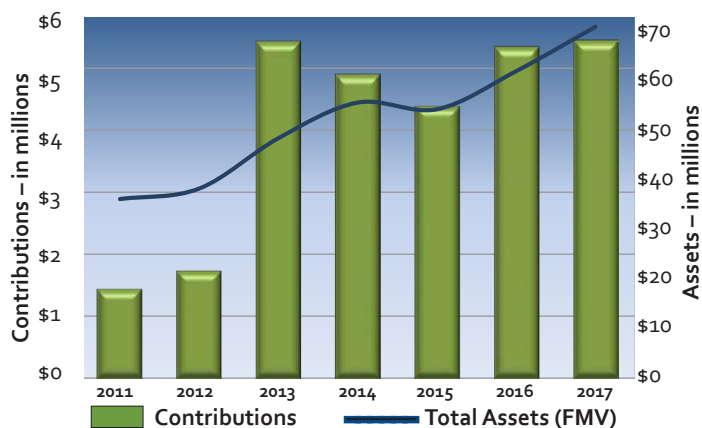


Chart I - Historical contribution trend

During 2017, the Foundation reached another milestone as total contributions exceeded \$5.4 million, surpassing the previous record established in 2013. For five years running, contributions to charitable funds held by the Community Foundation have been in excess of \$4 million. As the chart demonstrates, the Foundation has shown a steady, dramatic increase in assets beginning in 2013 as a result of this sustained giving trend. The continued charitable support is attributable to both individual donors, who have experienced the benefits of investing philanthropic dollars in the Foundation, as well as organizations utilizing the investment knowledge and experience offered by the Community Foundation.

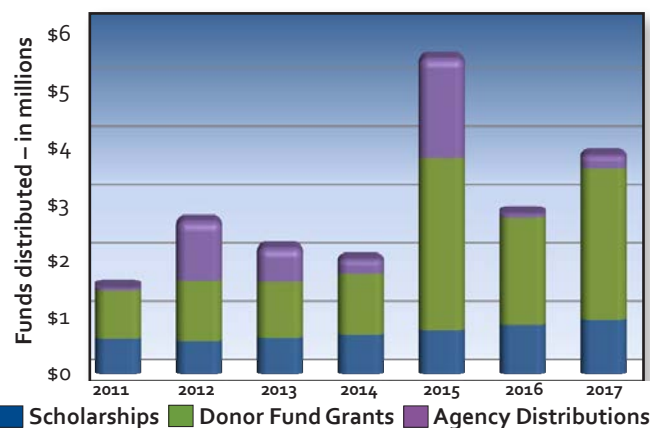


Chart II - Charitable distributions by type

The Foundation has three primary types of distributions: student scholarships; charitable grants from advised, designated, unrestricted and field of interest funds; and agency fund distributions requested by the respective non-profit organization. The chart demonstrates that while there can be significant fluctuation from year to year, depending upon our fund holders' charitable recommendations, there has been a steady upward trend of grants and scholarships awarded annually. Other than 2015, when the Foundation and our donors distributed a record amount of grants, distributions to other organizations has followed a trend consistent with the growth of assets held by the Foundation.

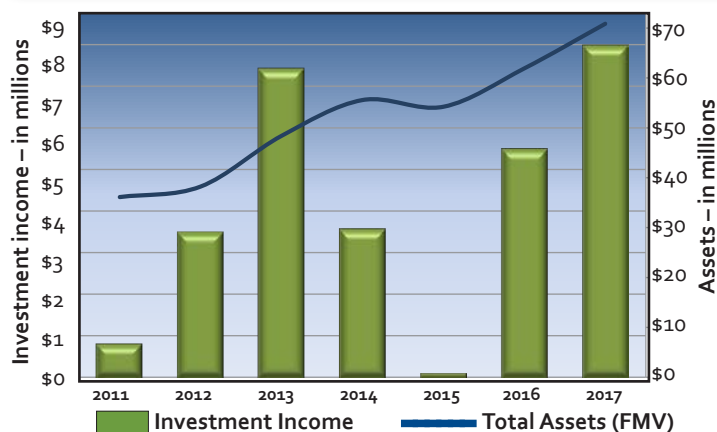


Chart III - Historical investments trend

During the most recent five-year period, assets held by the Foundation have benefitted from market growth averaging nearly nine percent, after investment fees. However, this chart indicates on a short-term basis the volatility of the investment market. The Foundation sets its spending policy to account for these fluctuations and to allow for a less volatile grant distribution process. This ensures more consistent cash flow to the organizations and students we support.

Grantees of the Community Foundation

Non-scholarship grants awarded by the Community Foundation in 2017 totalled more than \$2,595,000, and benefited 155 different charitable entities. Sources of these grants included donor-advised funds (page 16); designated funds (page 17); and a combination of field of interest funds (page 19) and unrestricted funds (page 22) distributed by the Foundation board. An additional \$937,000 was distributed for student scholarships, which are listed beginning on page 14.
