# New Philanthropy incentive sparks record fund creation

while investment markets languished for most of 2015, local donors to the Community Foundation of Mount Vernon & Knox County broke records by creating 28 new charitable funds. The gifting of more than \$4.5 million during the year set the stage for a robust market rebound, and expansion of the Foundation's asset base in 2016.

Thanks to the three-year old Ariel Corporation New Philanthropy matching gift incentive, fully half of those new donor-advised, designated, and scholarship fund creators benefitted from an immediate 50 percent addition to their funds.

Many other donors took advantage of the New Philanthropy match to magnify gifts made to funds that have been in existence for several years. Individual donors can claim up to \$25,000 in matching funds per year when they contribute at least \$10,000 to a new or existing endowed fund of their choice.

Since Board Chair Karen Buchwald Wright began offering the matching grants from the Ariel Corporation Donor-Advised fund in 2012, nearly \$1 million in matching funds have been distributed, more than 40 new funds have been created, and more than \$2 million in matched gifts has been added to the Foundation's endowment.

Without a doubt this has been the most expansive period in the 71-year history of the Community Foundation, and the charitable grants that will be generated by these new funds are certain to benefit our students and our communities for generations to come.

Major projects funded by the Foundation on a competitive basis, such as accessibility improvements to the Knox County Memorial Building and enhancements to The Learning Center in the former West Side Elementary School building, understandably attract the most public attention (see a complete list of competitive grants awarded beginning on page 21). But we encourage you to also review the complete catalog of funds (begin-

ning on Page 8) to fully appreciate the range of non-profit organizations and scholarship recipients who benefitted from more than \$5 million in Community Foundation grants in 2015.

As is our custom, we will close this "Year in Review" with a listing of the 28 new funds created during our most recently completed fiscal year.

Together with Finance Director Marc Odenweller and Program Manager Lisa Behr, both recent additions to our staff, I invite you to partner with the Community Foundation to realize your philanthropic ambitions. Perhaps next year we will be announcing a new charitable fund bearing your name!

# EXECUTIVE DIRECTOR'S YEAR IN REVIEW

### **New Donor-Advised Funds**

- The Mary M. Frank Fund was established by Wayne and Charlotte Frank and others to benefit various charitable interests of the late Mary Frank. Initially the fund will benefit the Pleasant Street Elementary School Library, Interchurch Social Services, and Habitat for Humanity of Knox County.
- The Chloris A. Fritz Memorial Fund was created by Blake Fritz in memory of his wife, and will initially provide support for Distinguished Young Woman of Ohio "Service Above Self Leadership Scholarships," awarded in memory of Chloris Fritz.
- The Douglas R. and Dianne W. Mack Fund was created by the Macks to provide income for flexible grant-making, initially at their discretion, and eventually at that of the Foundation board.

## **New Designated Funds**

# Major grants directed to school, college and civic building projects

Heavy equipment has been omnipresent around Knox County in recent months, and much of the new and restorative construction has been aided by 2015 unrestricted grants awarded by the board of the Community Foundation of Mount Vernon & Knox County.

A complete list of grants and scholarships awarded from the discretionary funds of the Community Foundation, chiefly its Unrestricted Grants Fund, begins on page 20. The top 10 community causes supported by these funds in 2015 were as follows:



# \$75,000

## Kenyon College

Kenyon has undertaken a massive renovation of the downtown Mount Vernon Buckeye Candy Building in anticipation of a 2017 relocation of its film studies department and Kenyon Office of Community Partnerships, and its provision of a permanent home for the Science Play Initiative "SPI Spot" interactive education center. The grant includes distributions from the Harold and Roberta Johnson Fund.

# **Foundation Park Conservancy**

This grant from the Harold and Roberta Johnson Fund and the William and Peggy Stroud Fund fulfills the Foundation's \$250,000, commitment to the Ariel-Foundation Park development effort. The multi-year park project, which re-purposed an abandoned gravel guarry and the former Pittsburgh Plate Glass factory, celebrated its grand opening on the Fourth of July with a full day of festivities, including three concerts and a spectacular fireworks display.





# **Knox County Commissioners** The addition of an elevator to the Knox County Memorial Building, and the modernizing of rest rooms, makes all three floors of the iconic structure accessible, and more inviting for community use. The Harold and Roberta Johnson Fund

Woodward Development Corp. As renovation of the Woodward Opera House, and surrounding performance, meeting and retail spaces, proceeds to completion, this grant fulfills a 2015 Foundation commitment made in anticipation of the final phases of construction.

## **Mount Vernon City Schools**

The foundation was pleased to facilitate long-needed physical improvements to the former West Side Elementary School, currently housing The Learning Center, an alternative education site serving an at-risk population under the auspices of the Knox Educational Service Center. The Sue Webster Fund participated in this grant.

### \$25,000

St. Vincent dePaul School Modifications to the school building, required to insure the security of students and staff, were completed in time for the opening of school in the fall of 2015.

### \$20,000

### Special Projects Fund

This grant is the annual transfer of funds to enable future green space acquisition and development. Prior year Special Projects Fund grants have provided for the purchase of several Knox County parks, such as Wolf Run, the Falls at Honey Run and Ariel-Foundation Park.

### MTVArts, Inc.

Approaching its 10th year of existence, MTVArts, Inc., launched a "Chasing Your Dreams" campaign to make major improvements to its rehearsal and storage site in downtown Mount Vernon. MTVArts is best known for its Broadway-style summer musicals, dinner theaters, and educational dramatic programming throughout the year.



## **Knox County Agricultural Museum**

The expanding collection of this popular museum, located within the Knox County Fairgrounds, necessitated the construction of a storage/work facility. Though not open for public access, the new building allows for the acceptance of artifacts not yet in the collection.





# **Ariel-Foundation Park** milestones, 2000-2015

Community Foundation provides \$151,000 to City of Mount Vernon to acquire initial 86-acre "Foundation Park" parcel, including two lakes, along the Kokosing.

City of Mount Vernon awarded Clean Ohio Grant to purchase additional of acres , adding a third lake, additional river frontage, and a western entrance to the park via Harcourt Road.

2009 Mayor Richard Mavis créates the Foundation Park Conservancy to develop a master plan that will maximize the recreational and economic benefits of Foundation Park.

### 2010

Community Foundation awards a grant to the City of Mount Vernon to assist in the purchase of a major right-of-way adjacent to Foundation Park that will be needed to link the Heart of Ohio Trail and the Kokosing Gap Trail.

A year-long planning process with Van Valkenburg and Associates of New York and Boston fails to produce a buildable park plan. Ted Schnormeier volunteers to develop a park master plan with Robert Stovicek, who had collaborated in the design and construction of Schnormeier Gardens in Gambier.

# 2013

Foundation Park Conservancy receives a \$1.75 million grant from Ariel Foundation, enabling the Valentine's Day purchase of the 75-acre former Pittsburgh Plate Glass property to the south. The expanded park is renamed "Ariel-Foundation Park" in honor of its two major benefactors. A master plan is presented and adopted by the Conservancy in April, and work begins immediately in the Woods and Lakes areas, as does a major renovation of the CA&C Railroad Depot. Demolition of, and recycling of building materials from, the PPG factory site, also gets underway.

Terraces and reflecting ponds begin to appear in the upper park during the spring and the CA&C Depot is rededicated. In July the restored Phoenix Bowstring Bridge is placed into commission, and the enhanced Lakes and Woods areas of the lower park are presented to the City.

**Project Director Ted Schnormeier battles** inclement weather throughout the spring of the year, but completes work on the Tree of Life Labyrinth, Rastin Tower, Urton Clock House, Community Foundation Pavilion and the Schnormeier Event Center. An estimated 10,000 people attend gala opening of Ariel-Foundation Park on July 4, punctuated by a brass band concert, laser light show, and spectacular fireworks display.


The Community Foundation of Mount Vernon & Knox County in 2015 received contributions in excess of \$4 million, which represents a small decrease from those of 2013 and 2014, but still above the Foundation's 10-year historical average. Gifts received were divided evenly between two sources. The Foundation received nearly \$2.1 million from



donors (individuals, estates, and businesses), including gifts that created 21 new donor funds. The Foundation also received assets in excess of \$2.2 million from Knox County non-profit entities, increasing the number of organization funds within the Foundation to 37. These pooled investments offer local non-profit organizations the prospect of increased returns and greater diversification in the investment of their reserve funds.

Contribution revenue shows significant historical fluctuation due to the unpredictable arrival of estate gifts, which typically are among the largest gifts received by the Foundation. During 2015 approximately \$450,000 was contributed to the Foundation by various estates. For comparative purposes in 2014 more than \$900,000 was received from estates, and in 2013 that total approached \$2.7 million.


Grants distributed from donor funds in 2015 approached \$3 million, compared to \$1 million the previous year. This included a generous grant from the Ariel Corporation Donor Advised Fund of more than \$1.5 million for the new Ariel-Foundation Park in Mount Vernon. Also during the year, non-profit agencies distributed more than \$1.7 million from their organization funds for operating and capital projects.





The 2015 investment year was a period of great turbulence registering the lowest returns since the world-wide market collapse in 2008. Both the Dow, down 2.2%, and the S&P 500, down 0.7%, retreated in the face of economic uncertainty. Prudent investment practices, nonetheless, allowed the Foundation to register a minimal market gain for the year.







### Chart I - Historical contribution trend

This chart demonstrates the fluctuation in total giving annually and the effect of contributions received on the Community Foundation's total assets. While contributions from individuals remain relatively consistent year to year, large estate gifts and contributions from non-profit agencies into organization funds are unpredictable. Note how contributions in 2013 included an unprecedented level of proceeds from estate gifts – more than \$2.5 million – resulting in a marked upward shift in the trend line.

# Chart II - Charitable distributions by type

The Foundation has three primary modes of charitable distribution: scholarships; charitable grants from unrestricted, designated, field of interest, and advised funds; and organization fund distributions requested by various non-profit agencies. This chart illustrates the increase in distributions in 2015 due to several large donor-advised grants, as well as an increase in distributed agency funds.

### Chart III - Historical investments trend

Market performance has a dominating impact on the asset value of the Foundation from year to year. Large asset growth occurs in years with correspondingly large investment income; but as seen in 2015, poor market performance has a similar negative impact on the value of Foundation holdings. The current year's decrease in total assets was a result of both a declining investment market and an increase in the dollar value of donor-recommended grants from advised funds.
